- 1. Club Membership Required:** Before signing up for a trip, you must be a current member of Harford Ski Club, Inc. or a current member of any club in the Blue Ridge Ski Council (if the trip is BRSC-sponsored or if the trip is sanctioned). Your membership in a BRSC club will be verified. HSC dues year is May 1 thru Apr 30.
- 2. Changes to Trips:** Harford Ski Club, Inc. reserves the right to make changes to trips, including, but not limited to, price, time, departure point, dates, lodging, etc., where such changes are in the best interest of the Club or are compelled by circumstances beyond the Club's control. Neither Harford Ski Club, Inc. nor its representatives assume any obligation or responsibility for any matters not within their control.
- 3. Required Deposits:** \$500 for flight trips, \$100 for bus trips. Make a check payable to Harford Ski Club, Inc., and mail it with this application to Harford Ski Club, Inc., PO Box 726, Havre de Grace, MD 21078. Early payment in full is greatly appreciated.
- 4. Cancellation Policy and Fees:** All cancellations must be made in writing or by email and directed to the trip leader. An administrative fee (\$50 for flight trips, \$25 for bus trips) will be charged for all cancellations except when the date or destination changed after a member signed up for the trip, or when the price exceeds the estimated published price range in effect at the date of sign-up by 5% or more (excluding additional airline taxes and surcharges). Refunds (less administrative fees) will be made only if a replacement person is found. If no replacement is found, expenses, airline and hotel deposits not recoverable by Harford Ski Club, Inc. will be deducted from the refund. If you cancel your trip and someone replaces you, you will be charged any costs the Club incurs to process the replacement person (e.g., airline ticket name change fee).
- 5. Trip Insurance:** You are highly encouraged to purchase trip insurance with trip cancellation coverage. See [harfordskiclub.org](http://harfordskiclub.org) for more information.
- 6. Payment Rules:** Trip participants shall not be given airline tickets, lift tickets, etc. until their trip is paid in full. Each member is responsible for all taxes, fuel surcharges, and other expenses that may accrue to the club as a result of their participation. Any additional surcharges and/or taxes in effect for the dates of travel that are applicable will be collected prior to travel. On international trips, currency fluctuation may result in an additional balance due which must be collected prior to departure. Individuals are responsible for any damages that they may cause to lodging or resort facilities. The failure to pay any such expenses may result in automatic suspension. Moreover, any outstanding debt will be recovered from any deposit currently held in escrow for future trips.
- 7. Bounced Checks:** There shall be a charge of \$10.00 plus any bank fees paid to the Harford Ski Club, Inc. for each bounced check submitted for a trip payment.

"Whereas I recognize that any activity, travel arrangements, or trips associated with the Harford Ski Club, Inc. its Officers and Board of Directors, and a trip or activity leader, or any agent thereof may be hazardous by reason of the nature of the activity, travel arrangements, or trip.

"Therefore in consideration of being allowed to participate in any Harford Ski Club Inc. activity or trip, I, the undersigned voluntarily waived, hold harmless, and covenant not to sue Harford Ski Club, Inc., its Officers and Board of Directors, any trip or activity leader, or agent thereof with respect to any and all claims of liability of any kind arising out of any trip or activity with the Harford Ski Club, Inc.

"Further, I accept the continuing responsibility to acquaint myself with the hazards and risk inherent in any Harford Ski Club, Inc. activity or trip, and I agree not to participate in any such activity unless I fully understand or risk attendant thereto.
